

ABOUT THE AREA

The approximately 27,000-acre El Mirage Off-Highway Vehicle (OHV) Recreation Area is managed by the Bureau of Land Management (BLM) and is located in the Mojave Desert on the western edge of San Bernardino County. This Off-Highway Vehicle riding area attracts enthusiasts of a wide range of recreational vehicles that include motorcycles, ATVs, trucks, cars, buggies, land yachts, ultralight aircraft, gyrocopters, para-sails, and full sized aircraft.

Elevations range from about 2,800 feet at the El Mirage dry lakebed to over 3,800 feet in the Shadow Mountains. During summer, temperatures can reach 120 °F and thunder storms can arrive with spectacular force; although most precipitation falls during the winter. In winter, temperatures at night can fall as low as 5 °F.

PERMIT FEES

IMPORTANT RULES & REGULATIONS

IF THERE IS TRASH AT YOUR CAMPSITE, IT'S <u>YOUR</u> TRASH!

PACK IT IN, PACK IT OUT! THERE IS NO TRASH SERVICE FOR VISITORS

- · Firewood materials containing nails, screws, or other metal hardware, such as wood pallets and construction debris, are prohibited.
- NO SHOOTING within the El Mirage OHV Recreation Area. This includes, but is not limited to, firearms, bow & arrows, BB guns, and
- · Do not operate an OHV while under the influence of drugs or alcohol.
- All ATV and ROV riders and passengers must wear a helmet. It is advisable to also wear boots, gloves, and eye protection.
- A maximum speed limit of 15 miles per hour must be observed within 50 feet of all campsites and staging areas.
- OHVs owned by California residents must be registered with the California Department of Motor Vehicles (DMV) and must display a valid "Green Sticker" or "Red Sticker" permit.

 Any person operating an ROV shall be at least 16 years of age, or be directly supervised in the vehicle by a parent, guardian or by an authorized adult.

· Glass containers of any kind are prohibited in the open area.

- · Fireworks are prohibited within the open area.
- · OHVs must be equipped with an approved muffler, brakes, and
- · Motorized vehicles should yield to non-motorized vehicles and aircraft on the lakebed.
- California requires Non-Resident Permits for OHVs visiting from states that do not honor California OHV Identifications. (AZ, CO, ID, MT, NV, NM, OR, TX, UT, WA, WY.)
- For your safety and the safety of the sensitive species within, do not enter mineshafts. STAY OUT, STAY ALIVE!

1. EL MIRAGE DRY LAKEBED

This unique, 4,800-acre dry lakebed is the most popular feature for visitors in the El Mirage OHV Recreation Area. The flat and smooth surface is perfect for many specialized forms of recreation. When wet, the lakebed's surface is pliable, and is easily damaged by vehicle use. Staying off of the lakebed during closures allows the surface to naturally heal thanks to the smoothing effects of water and wind, and enables more forms of recreation across more of the lakebed when dry

2. SHADOW MOUNTAINS

The northern area of El Mirage is home the rugged Shadow Mountains. These peaks are appropriate for expert riders, while new or less experienced riders should enjoy the other popular riding locations within the OHV Recreation Area like the Twin Hills Area. Do not enter any of the abandoned mines in the area as they are unsafe for visitors, and often serve as important habitats for bats and other species that live in dark places.

3. THE BASIN

The Basin lies between the lakebed and the mountains to the north and east. Most trails that traverse it are suitable for average riders, however, there are a few places in the Basin that may prove to be a moderate challenge for experienced riders. The Basin is home to a diverse variety of desert vegetation that is important to the habitat of numerous species, and helps to control erosion and dust

4. TWIN HILLS AREA

The Twin Hills riding area is located in the northeast section of the park between U.S. Highway 395 and the Shadow Mountains, which isolates it from the lakebed. Visitors find this a great place to camp, and the Twin Hills are easier to ride than the trails of the rugged Shadow Mountains.

ACTIVITIES AT EL MIRAGE

EL MIRAGE OHV SKILLS TRAINING COURSE

The Friends of El Mirage offers ATV Safety Institute certified classes with ASI Certified instructors on a custom-built safety course near the Visitor Center at El Mirage. Here, students practice basic safety techniques, learn about safety equipment, OHV rules and regulations, and learn hands-on techniques for navigating hill climbs, obstacles. collision avoidance and more.

Classes are offered at El Mirage the second Saturday of every month, with the exception of July and August.

WIND POWERED VEHICLES

Strong winds are frequent occurrences at El Mirage, making it a prime destination for wind sports enthusiasts. With wind speeds capable of reaching over 60 miles per hour, wind vehicles are challenging to maneuver and should always be given the right of way.

ULTRALIGHTS, GYROCOPTERS, AND OTHER AIRCRAFT Personal aircraft are a major attraction on the lakebed because the flat

area provides plenty of room to take off and land safely. Land vehicles are required to give full right of way to all air vehicles.

SOUTHERN CALIFORNIA TIMING ASSOCIATION

During the dry months of summer and fall, the Southern California Timing Association (SCTA) hosts time-trial races and seasonal twoday events. Speeds of over 300 miles per hour have been recorded at these events. SCTA has exclusive use of the western end of the lakebed during these events. Safe, high-speed travel depends on the smooth surface of the dry lakebed. Help protect the surface by observing lakebed closures and avoiding destructive driving. LOST PERSON

If a member of your party becomes lost, remain calm. Make note of the last time and place the person was seen. Call 911 to report the missing person.

INJURED PERSON

Avoid moving an injured person unnecessarily, as this could harm them further. In most circumstances, it is better to wait for medically trained emergency personnel to arrive on the scene, rather than moving the injured person. Utilize common sense and care when deciding whether moving the injured person is necessary for their survival
